#### 6. BID OFFICE REPORT

#### **Future Oswestry Group**

Using FOG to push SC to obtain costs for Church Street so we can progress. Gave updates re: Levelling Up Fund Bid by SC.

FOG group still not happy about the proposed footbridge over the A5 and noted it was not fit for purpose.

# **Heritage Action Zone Group**

Alleyway work is ongoing but shopfronts and upper floor re-purposing work is nearly completed. We have requested that SC be quicker on communications, and if necessary, BID can take photos write some copy and issue PRs to get information out to businesses and the public quickly and in an interesting and inviting format.

#### **Vehicle Activated Signage**

Vehicle activated speed signs have been ordered and should be installed around the industrial area in August.

#### **EVENTS**

Preparations for this year's Balloon Carnival are pretty much all ready, just pushing out posters/PR now to raise awareness of the event.

# **VEHICLE TRACKING SYSTEM INDUSTRIAL ESTATE**

There have been problems with the data collection and ORP (suppliers) are trying to resolve with their IT company but if not, a full refund will be issued September.

#### **CCTV**

Updated quotes and details passed to OTC for proposed extension onto Artillery Business Park and once they have confirmed these are okay, we can progress. They have already approved in principle.

#### **SPORTS DIRECT ALLEY**

We have been trying to ascertain ownership of the "Sports Direct" Alley in order to develop plans to improve it in line with other town centre alleys. Contact has been made with Sports Direct, but no response has been received regarding ownership or permission. We are also still chasing SC re: ownership of the alley.

# WAYFINDING

We have identified another 16 lamp post positions for additional banners on the industrial estates to enhance the signage. Just waiting for surveys to be completed then we can order and arrange installation.

### **TAXIs**

A meeting took place on 27<sup>th</sup> July 2022 between key stakeholders and interested parties regarding Oswestry's taxi service. There seems to be a number of restrictions that exist in Shropshire that do not exist in other Council areas. These issues are being considered.

Next meeting will be in September.

#### RICKSHAW PROJECT

The rickshaw operators have provided an update on their current progress and what they have initially achieved since setting up. They have made a number of community links as well as some important links with businesses.

# **TRAINING**

We have started looking at some other training courses from December through till March 2023. These include a Financial Skills Workshop with Frances Riseley, who has been running our business support program, and a Loss Prevention Training course to help combat shoplifting.

Ongoing issue of many businesses failing to attend courses or cancelling very late notice. We will be reviewing how to deal with these in next few weeks.

#### **PUBWATCH**

Still having poor attendance at Pubwatch meetings and it's been agreed that we are going to do a work around with the Police to discuss attendance.

Next meeting 16<sup>th</sup> August.

#### **SHOPWATCH**

We have made contact with a few shops to discuss the DISC reporting system and shoplifting. However, we haven't received a single response to either email sent out to discuss Shopwatch or DISC.

#### **NIGHTBUS**

114 passengers for the June, still low, however higher than the last month.

We have met with Tanat (bus operator) to discuss the routes and are looking to make some amendments to see if that can help the figures.

SP suggested Night Bus beer mats to promote the night bus service to customers. These have been thought about, and can be considered again.

#### FOOTFALL/WIFI

Footfall did increase from previous weeks at the Food Festival, although the following week was even higher, which may partly be due to people returning to the town after the festival. Highest visitor figure for July thus far is Thursday, 7th July, with 14361.

An example comparison of Oswestry footfall with West Midlands towns is presented below and shows that the town is faring well be comparison.



WiFi registered users continues to grow steadily, now at 1,334. June – 21,549 connections, average 718 connections/day.

#### NIGHTBUS WRAP

The planned vinyl wrap to help promote the night bus service is in production and should be installed soon.

#### 7. Church Street

We continue to wait for the costings for the proposed works on Church Street from WSP (SC's consultants).

There have been ongoing discussions regarding textured print for footpaths versus other more traditional alternatives. Environmental Associates (our consultant) has provided a strongly worded email against the use of this type of finish in a conservation area. Dr Andy Wrigley (SC) has also provided the view that this wouldn't be acceptable either.

# 8. BID 2<sup>nd</sup> Term Campaign – Business Plan

AN confirmed that we have discussed the renewal process with the Elections Team at SC.

Next step is to draft up the Ballot Statement and undertake a Data Base clean-up to ensure the information regarding businesses eligible to vote in the Ballot is correct. Once the 2<sup>nd</sup> Term Business Plan is finalised on 15<sup>th</sup> August 2022, we will then also be printing the Business Plan and posting and emailing this out to Levy Payers.

We will also ensure that the BID Ballot is publicised in the Advertiser and Oswestry Life.

AN confirmed that she is attending an OTC meeting in September to present our 2<sup>nd</sup> Term Business Plan.
