Rebecca Jones explained that there were no first year Annual Accounts for Oswestry BID Ltd. She outlined the income and expenditures for the Ballot procedures, and explained where the funding came from (Shropshire Council and Oswestry Town Council) and what it went on (BID consultancy provided by PFBBUK – a mandated requirement from both Councils to enable the BID ballot team to act in accordance with BID Ballot requirements set out by Government).

Agreement of Accounts

Whilst the financial figures represented were in draft state, albeit presented as accurate at the time of presentation, the accounts as stated were agreed on by those present. Full company accounts are being prepared by independent accountants and are expected to remain consistent with the position as reported.

Appointment of a new Board of Directors

Heather Noble explained that as per the Articles of Association all current Directors had stood down, but, as entitled, have all put themselves forward for re-election. As there were no other nominations received, there was no requirement to hold a formal ballot, therefore all re-elections would be voted by a show of hands.

Heather then explained that those standing for re-election were made up of 4 Company Member, two Independent and two Voluntary Member representatives.

All standing for re-election were unanimously voted in.

Proposed amendments to Articles

Heather Noble outlined the proposed amendments to the Articles, and the reasonings behind them,

- 1. To increase the maximum number of Directors allowed from 9 12. In doing so the maximum number of Member Directors would increase from 7 to 9 and the maximum number of Voluntary Directors would increase from 2 3. Other limits would not change.
- 2. To remove the reference to Local Authority Directors. This would bring the Articles into line with the Business Plan that was subject to the successful ballot which stated that:

'[The Board] will include one senior officer from Shropshire Council and one senior officer from Oswestry Town Council who will act as key operational links to council services but not as Directors'.

Both amendments were approved unanimously.

Other business

Heather Noble introduced Adele Nightingale – Oswestry BID Manager. Adele outlined what her role was and what she planned to be doing within the next six months in working with both town centre and industrial estate business owners.

There being no further business, the Chairperson thanked everyone for attending and pronounced the meeting closed.
